Thank you for email of 17 June 2024 requesting under the Local Government Official Information and Meetings Act 1987 (LGOIMA), information relating to the increase in dog registration fees. Please see outlined below a response to each part of your request.

The balance sheet for animal control showing expenditure/income

Financial figures for the Dog Control and the Animal Control functions for the 2022/23 & the 2023/24* financial year are provided in *Table 1* below.

You will see that the Dog Control and the Animal Control figures have been reported separately, this is because it is the Dog Control figures that relates to the dog control activity which is part-funded by the dog owner and part-funded by rates. The Animal Control figures relates to stock control and animal bylaw related activities.

Revenue from dog registration

Dog Control income received for dog registration fees for the 2022/23 financial year was \$489,980. Dog Control income received for dog registration fees for 2023/24 was \$541,730*.

Councils Revenue and Financing Policy sets out how much of the cost to deliver a service is funded by the dog owner and how much is funded by the ratepayer. For the Dog Control activity, the revenue and financing policy informs that 80-90% of the cost to deliver the service should be funded by the dog owner, and 10-20% through rates.

In March/April 2024 Council carried out a consultation process with the community on the Long Term Plan 2024/2044, this is a legal requirement of Councils and is the opportunity for any member of the public to share their ideas, discuss important topics such as what activities should be ratepayer funded and what activities should be funded by the primary user, as well as enable the community to give feedback on policy, planning, and proposed fees and charges. The fees in place are the result following the consultation process.

*Again, financial figures for the 2023/24 financial year are still to be finalized. This is because the year only finished on 30 June 2024.

Expenses/income incurred for wages/impounding fees/running fees for the pound/vehicle costs etc

Total expenses for the Dog Control and Animal Control functions are included in the table above, this includes the costs for wages, running the pound and vehicles.

The total income is also income for dog impound fees collected is in *Table 2* below:
