Thank you for your email dated 21 November 2024 requesting under the Local Government Official Information and Meetings Act 1987 (LGOIMA), information relating to dog control activities. Please see outlined below a response to each part of your request.

Dog registration fees and charges for 2023-24 were consulted on as part of Councils Annual Plan 2023/24 process. Notice of the review of the dog control fees and charges was published in the Community Connection pages in the Horowhenua Chronicle, dated 16 June 2023; and notice of dog registration fees being due was published in the Community Connection pages of the Horowhenua Chronicle on 7 July and 21 July 2023. A media release was also published on Councils website, and sent to media contacts on 2 June 2023.

In relation to the dog registration process:

a. The application form and all other information or documents provided to a person seeking to apply to register a dog for or during registration years 2023-24 & 2024-25.

A dog owner can register their dog online via Councils website, or in person at a Council Office or Service Centre.

b. All documents and information provided to a person from whom an application to register a dog has been received for or during registration years 2023-24 & 2024-25.

Upon review of the dog registration process as prompted by this request, it has been identified that no written information was provided to dog owners following the registration of a dog. It was intended that the back page of the registration form was to be given back to the owner, however in recent years this information has been printed on the reverse side of the registration form and retained by Council.

This has since been changed, and now a copy of what was the back of the registration form is being provided to dog owners. A copy of this information is attached.

Dog registration fees for 2023-24 were reviewed and set as part of the annual plan process for 23/24 that happened alongside our Councils 2021 - 2041 Long Term Plan Amendment (LTPA) process. Public consultation on both happened from 13 March to 14 April 2023, and the fees formally adopted with the final LTPA and Annual Plan at the extraordinary meeting held on 28 June 2023.

Dog registration fees for 2024-25 were reviewed as part of the 2024-2044 Long Term Plan (LTP) process, which also included a review of Councils Revenue and Financing Policy. The Revenue and Financing Policy sets out the Council's activities, services, and facilities (what we do and why we do it) and who uses, benefits, and should pay for them. For the dog control activity, it informs that 80-90% of the cost to deliver the activity should be funded by



the dog owner, and with the remaining 10-20% funded through rates. Public consultation happened from 15 March to 15 April 2024, and with the 2024/25 fees being adopted at the 19 June 2024 meeting of Council, and prior to the final LTP being adopted on the 26 June 2024.

Dog owner responsibilities

If you're registering your dog in the Horowhenua District for the first time, or transferring your dog from another area, there's some important information and obligations you need to understand and agree to as part of the registration process.

Notes on Registration

All dog owners with dogs ordinarily kept in the Horowhenua District must register with the territorial authority (Horowhenua District Council).

All dogs **over the age of three months** must be registered. It's an offence to keep a dog older than three months which is unregistered. On conviction, a Court may impose a fine of up to \$3,000.

The completed application form, together with the fee payable, must be completed online, posted to the Dog Registrar, Horowhenua District Council, Private Bag 4002, Levin or delivered to Horowhenua District Council's main office. It's an offence when making an application for the registration of a dog to make any written statement knowing that statement to be false. On conviction, a Court may impose a fine of up to \$3,000.

Dog tags (discs)

Replacement discs may be collected from the Horowhenua District Council if the current disc has been lost or stolen. Any dog that isn't wearing a collar that has a current registration label or disc attached will, until proven otherwise, be deemed to be unregistered.

Change of ownership

On change of ownership of any registered dog, both the previous owner and the new owner must give written notice to Horowhenua District Council within 14 days of the change of ownership. This notice must include the residential address of the new owner and the address at which the dog will be kept. It's an offence not to comply with this requirement. On conviction, a court may impose a fine of up to \$500.

Change of address

If the owner's address changes within the district, the owner must give written notice of the change to Horowhenua District Council within 14 days.

Transfer of dog registration

If any dog is transferred to and kept in the district of another territorial authority, other than the one in which it has been kept, for one month or more the owner must give written notice of the transfer to both authorities within six weeks of the transfer. This notice must set out the address at which the dog will be kept. It's an offence not to comply with this requirement. On conviction, a court may impose a fine of up to \$500.

Deceased dog

Where the fee for the registration of a dog is paid and that dog dies, a refund will be made on request as follows:

- where a dog dies before the commencement of the year, the full fee will be refunded;
- where the dog dies during the year, one-twelfth of the

annual fee for each complete month remaining in the registration year after the date of application for a refund will be refunded.

Registration fees

Where any dog is first required to be registered after 1 August in any registration year, the fee shall be one-twelfth of the annual fee for each complete month remaining in the registration year after the date of that registration. The registration fees include GST. Owners wishing to claim a reduced fee for desexed (neutered) dogs must produce a veterinary surgeon's certificate certifying that the dog has been desexed.

If any dog over the age of three months is found on land other than it's owners or in any public place and is not wearing a collar that has a current registration label or disc attached, the dog may be seized and impounded.

Control of dogs (Section 52, 53 and 65 Dog Control Act 1996)

The owner of any dog must keep that dog under control at all times and, when in a public place, must use or carry a leash at all times.

A dog will be deemed to be not under control:

- if it is found at large (loose or wandering) on any land or premises other than a public place or a private way without the consent (express or implied) of the occupier or person in charge of the land or those premises; or
- if it is found at large in any public place or in any private way in contravention of any regulation or bylaw.

You'll commit an offence and be liable on conviction to a fine not exceeding \$3,000 or an infringement fee of \$300 if you fail to comply with this provision.

Obligations of dog owners (Section 54, Dog Control Act)

The owner of any dog must:

- ensure the dog receives proper care and attention and is supplied with proper and sufficient food, water, shelter; and
- ensure the dog receives adequate exercise.

You'll commit an offence and be liable on conviction to imprisonment for up to three months or to a fine not exceeding \$5,000 if you fail to comply with this provision.

Obligations of dog owners on owner's property (Section 52A and 65, Dog Control Act 1996)

When the dog is on land or premises occupied by the owner, the owner of a dog must ensure:

- the dog is under the direct control of a person; or
- the dog is confined within the land or premises in such a way that it cannot freely leave the land or premises.

You'll commit an offence and be liable on conviction to a fine of \$3,000 or an infringement fee of \$300 if you fail to comply with this provision. In addition, a dog control officer or dog ranger may seize and impound the dog.





Dog Control Policy and Practices

Annual Report 2022-2023



Introduction

Section 10A of the Dog Control Act 1996 requires Council to report annually to the Secretary of Local Government on its dog control policy and practices. This report is to fulfil this requirement for the 22/23 financial year from 1 July 2022 to 30 June 2023.

Overview

Council delivers its Animal Control services in-house, with funding of the dog control component being a mixture of user pays (dog registration fees) and rates, as set out by Councils revenue & finance policy. During the 2022/23 year the Council adopted an amendment to the Long-Term Plan which saw a change in the level of user pays component in the funding of the dog control activity; to now recover 80-90% Private Good (through fees and charges) and 10-20% Public Good (through rates), from the previously set 70-80% Private Good and 20-30% Public Good (as applied for the financial year relevant to this report).

The Animal Control team is part of the Customer and Compliance team, which is in the Community Experience and Services Group at Council. During the 2022-23 year, the Animal Control team comprised of a team leader, four full time officers and two part time officers with support provided by a Customer Support Officer assisting the administration needs of the Animal Control function.

The Dog Pound is located on Council land off Mako Mako Road, Levin. The facility has kennelling for up to 28 dogs at any one time, housed within a large exercise yard. The Pound is closed to the public on a day-to-day basis, but provides an appointment-based system for owners of impounded dogs to collect their animal.

A review of Council's Dog Control Policy and Bylaw was undertaken in June 2015 and following the public consultative process was subsequently adopted in August 2015. This bylaw is due for review by June 2025.

This year the Animal Control team put focus on proactive communication around what our Animal Control and Compliance Teams provide to the Community, as well as concentrated effort on increasing our emailable dog owner database. This mahi has included the creation of new Dog Control electronic newsletter communication as well as improving our internal systems for receiving electronic notifications from owners. It also saw our team attending community events such as Neighbours Day 2022 organised by Levin Community Patrol.

Dog Numbers

The year started with a known 6,319 dogs on Council's Dog Database, decreasing to 6,090 known dogs by the end of the registration year.

For dog owners that did not register their dogs, and where the non-registration came to Animal Control staff's attention, infringement notices were issued to the dog owner for failing to register their dog/s. If the infringement notice was not paid, it was lodged with the Ministry of Justice for collection.

Council also offers a time payment arrangement for owners who may not be able to pay their dogs registration fees in full immediately. Time payment arrangements are offered by direct debit only, and are to be paid in full by 31 August.

Registration Notices for 2023/24 were distributed to all current dog owners in our database in the first weeks of July 2023. For the new 23/24 year dog owners, who elected to receive their registration renewal information via email, received an email on the 6 July 2023.

This is the third year Council has distributed dog registration renewal information in this way, and it is expected the number of dog owners wishing to opt into this service will continue to increase in the coming years as they have trended upwards in the last two years.

There has been a lot to celebrate since the last Community Connection.

On Sunday 4 June the doors opened to a new-look Youth

Space at Te Takeretanga o Kura-hau-pō after a short four-week closure while renovations took place. It has had a fresh paint job, new carpet has been installed and exciting new technology, games and furniture have been added to take our already popular dedicated Youth Space to the next level. This special and versatile spot for rangatahi aged between 12 and 24 years is a safe and exciting place to hang out at after school, in the weekends and in the holidays. It houses youth development programmes to help our young people gain resilience, feel connected and acquire real life capabilities, all while having fun.

As a Council, we are committed to investing in Community Facilities like the Youth Space, and we are excited to have received \$300,000 from the Lottery Community Facilities Fund towards the \$4.5M Waitārere Beach Surf Life Saving Community Facility which is currently under construction and coming along nicely.

There are a lot of future focused people in our community, and I am delighted that we have also secured funding to continue our Mayors Taskforce for Jobs (MTFJ) initiative for another two years. A nationwide programme with Local Government New Zealand (LGNZ) and the Ministry of Social Development (MSD), MTFJ focuses on connecting young people with suitable training, employment and mentoring opportunities. It helps to remove barriers to employment or training while providing a platform for job creation. Dog renewal registrations



You'll be able to renew your dog registration from 10am on Thursday 6 July, slightly later than our usual opening date of 1 July.

The extra time has allowed us to consult on Fees and Charges as part of the Annual Plan 2023/2024. Following public consultation, Council resolved to increase dog registration fees for the 2023/2024 registration period. The 2023/2024 registration period also sees the introduction of a new registration class so people who own four or more stock dogs will receive a \$10 discount per dog. The new fees and charges will be adopted at a Council meeting on Wednesday 28 June. The Dog Control and Animal Control activity costs have been separated in the Revenue and Financing Policy to reduce the public funding component for the Dog Control activity. Moving forward, through dog registration fees and related increased charges, dog owners will pay a higher percentage of the costs for these services to ease the burden on ratepayers who do not own canines. Dog registration fees will increase so that owners pay for 80-90% of Dog Control services as most of the benefit is 'private'. Be sure to renew your dog registration by Saturday 5 August 2023 to avoid a 50% late fee penalty. You can learn more about dog registrations and responsible dog ownership at

Dog Control Policy and Practices

Annual Report 2023-2024



Introduction

Section 10A of the Dog Control Act 1996 requires Council to report annually to the Secretary of Local Government on its dog control policy and practices. This report is to fulfil this requirement for the 23/24 financial year from 1 July 2023 to 30 June 2024.

Overview

Council delivers its Animal Control services in-house, with funding of the dog control component being a mixture of user pays (dog registration fees) and rates, as set out by Councils revenue & finance policy.

The Animal Control team is part of the Customer and Compliance team, which is in the Community Experience and Services Group at Council. During the 2023-24 year, the Animal Control team comprised of a team leader, four full time officers and two part time officers with support provided by a Customer Support Officer assisting the administration needs of the Animal Control function.

The Dog Pound is located on Council land off Mako Mako Road, Levin. The facility has kennelling for up to 28 dogs at any one time, housed within a large exercise yard. The Pound is closed to the public on a day-to-day basis, and provides an appointment-based system for owners of impounded dogs to collect their animal.

A review of Council's Dog Control Policy and Bylaw was undertaken in June 2015 and following the public consultative process was subsequently adopted in August 2015. This bylaw is due for review by June 2025.

Over the 2023/24 year, the Animal Control team extended their business hours to offer a wider range of services during the weekdays and on weekends to support the needs of the community. The operating hours for the animal control activity are Monday to Friday, 7am to 7pm, and Saturday to Sunday, 8am to 4:30pm, representing an increase from the previous hours of Monday to Friday, 7:30am to 4pm, with weekends limited to emergency after-hours services only. Thus, enabling the team to increase their focus on proactive officer patrols and collaborating with dog owners directly, to address and problem-solve recurring nuisance issues such as wandering and barking dogs.

Dog Numbers

The year started with a known 6,090 dogs on Council's Dog Database, increasing to 6,543 known dogs by the end of the registration year.

For dog owners that did not register their dogs, and where the non-registration of the dog came to Animal Control staff's attention, infringement notices were issued to the dog owner for failing to register their dog/s. If the infringement notice was not paid, it was lodged with the Ministry of Justice for collection. Council offer a time payment arrangement in advance, by way of direct debit or automatic payments for owners who may not be able to pay their dogs registration fees in full immediately. Any payment arrangements need to be paid in full by 30 June, before the start of the new registration year. Once paid in full, the new registration tag will then be sent out in July for the new registration period.

Registration Notices for 2023/24 were distributed to all current dog owners in our database in the first weeks of July 2023. For the 23/24 year, dog owners who elected to receive their registration renewal information via email, received an email on 6 July 2023.

This is the fourth year Council has distributed dog registration renewal information in this way, and it is expected the number of dog owners wishing to opt into this service will continue to increase in the coming years as they have trended upwards in the last three years.
