5.1 Gambling Class 4 Venue Policy - Consideration of Submissions

Kristy Kang and Gerhart Berking, from the PGF Group, attended the meeting via Zoom, and spoke in support of the existing sinking lid policy, and the general direction of overall policy. They would prefer a stronger stance against Class 4 gambling venues.

Elected members considered the proposed policy in light of the submissions received. The Committee directed officers to amend the policy at 5.1 to reflect new building standards for earthquake resilience for any venue, and at 7.2 to harmonise the reference to sensitive sites with that contained in clause 7.2 of the Local Alcohol Policy

MOVED by Cr Allan, seconded Mayor Wanden:

That after the consideration and hearing of submissions, changes be made to the Gambling Class 4 Venue Policy as follows:

Add a new sub-clause – "5.1d) The venue being relocated to meets or exceeds the New Building Standards for earthquake resilience."

Amend clause 5.2(5) to read — "Any new Class 4 Venue, temporary or permanent, will not be located closer than 150 metres of the legal site boundary of any school, early childcare facility, place of worship, Marae, health care facility, public park or reserve, urupa, or cemetery, and other community facilities."

That the Hearings Committee recommends to Council the adoption of the Gambling Class 4 Venue Policy, as amended, effective from the date of the adoption by Council, and the repeal of the 2017 policy.
